## **Schroder International Selection Fund – changes to the distribution policy of certain share classes**

Following a recent review, the board of directors of Schroder International Selection Fund (the "Company") has decided to change the distribution policy for some share classes (the "Share Classes") of the following sub-funds: Global Conservative Convertible Bond, Global Convertible Bond, Emerging Multi-Asset Income and Global Bond. The distribution frequency of these Share Classes will not change, but the fixed amounts paid out will reduce. Global Diversified Growth will change from quarterly fixed to quarterly variable distributions, which means that the amount paid out may increase or decrease from the current fixed level depending on the income generated by the fund during each quarter.

The affected Share Classes and the changes to the distribution policy are detailed in the appendix to this letter.

This change will come into effect for the distribution due to be paid on 7 April 2020 (the "Effective Date") and will apply to all distributions going forward.

The Share Class fees will remain unchanged and the cost of making these changes including regulatory and shareholder communication costs will be borne by Schroder Investment Management (Europe) S.A. (the Fund's management company).

We hope that you will choose to remain invested in the Fund following these changes, but if you do wish to redeem your holding in the Fund or to switch into another of the Company's sub-funds before the changes become effective you may do so at any time up to and including deal cut-off on 24 March 2020. Please ensure that your redemption or switch instruction reaches HSBC France, Luxembourg branch ("HSBC") before this deadline.

HSBC will execute your redemption or switch instructions in accordance with the provisions of the Company's prospectus, free of charge, although in some countries local paying agents, correspondent banks or similar agents might charge transaction fees. Local agents might also have a local deal cut-off which is earlier than that described above, so please check with them to ensure that your instructions reach HSBC before the deal cut-off on 24 March 2020.
