## Notice to investors

### Continuous Disclosure Notice (updated fees and costs) for Schroder Real Return Fund – Client Class

We are writing to inform investors, as the responsible entity for the Schroder Real Return Fund – Client Class (**Fund**), that we have assessed that the amounts disclosed in section 6 (Fees and Costs) of the product disclosure statement for the Fund (**PDS**) need to be updated based on amounts paid in the 12 months ending 30 June 2024. We have formed the view that the changes to the fees and costs disclosed in the PDS are not materially adverse to investors. Therefore, the fees and costs amounts are being provided to investors through this website disclosure rather than by issuing a new PDS. Accordingly, all references to fees and costs in section 6 of the PDS dated 14 December 2023, are to be read based on the amounts in the tables below.

Potential investors should read the PDS and this update in its entirety. Capitalised terms have the same meaning as in the PDS, unless stated otherwise.

#### Fees and costs

##### Did you know?

Small differences in both investment performance and fees and costs can have a substantial impact on your long-term returns. For example, total annual fees and costs of 2% of your investment balance rather than 1% could reduce your final return by up to 20% over a 30-year period (for example, reduce it from \$100,000 to \$80,000). You should consider whether features such as superior investment performance or the provision of better member services justify higher fees and costs. You may be able to negotiate to pay lower fees. Ask the Fund or your financial adviser.

Please note that this is just an example. In practice, actual investment balances will vary daily and the actual fees and costs charged are based on the value of the Fund, which also fluctuates daily.

## Additional explanation of fees and costs

### Management fee

The management fee is the fee for Schroders' services as Responsible Entity in overseeing the operations of the Fund and/or for providing access to the Fund's underlying investments.

The management fee that Schroders is entitled to receive is tiered depending on the NAV of the Client Class of units in the Fund at the time of calculation, as set out in the table below. Please refer to section 3, 'More detailed information about fees and costs' in the 'Additional Information to the PDS' for further details, including a worked example of how Schroders' management fee is calculated.

### Maximum fees

The maximum fees that Schroders is entitled to charge are set out in the Constitution.

The maximum management fee for the Fund under the Constitution is 5.13% (inclusive of GST and less any RITCs) per annum of the NAV of the Fund. The current management fee is in the range of 0.59% to 0.85% (inclusive of GST and less any RITCs) per annum of the NAV of the Fund.

Schroders is entitled to charge a performance fee for the Fund under the Constitution of up to 33.80% (inclusive of GST and less any RITCs) of daily performance above the benchmark for the Fund determined by Schroders. Schroders does not currently charge a performance fee in respect of the Fund.
