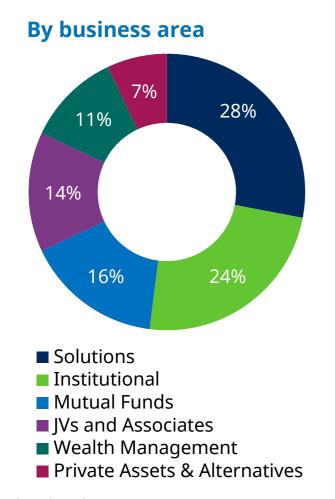

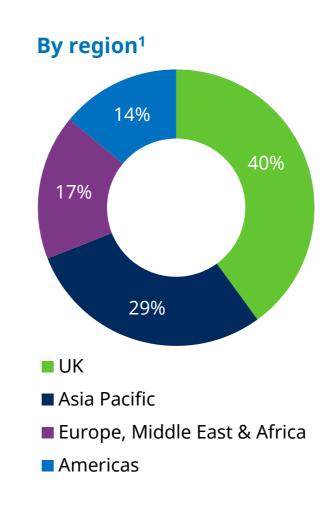


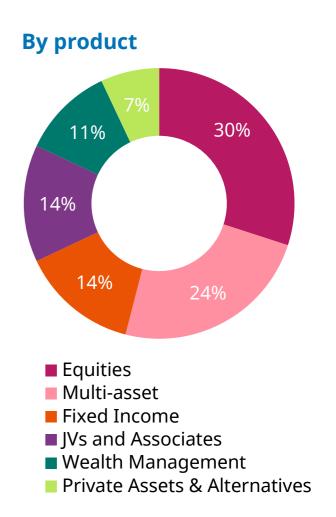

Assets under management £700.4 billion



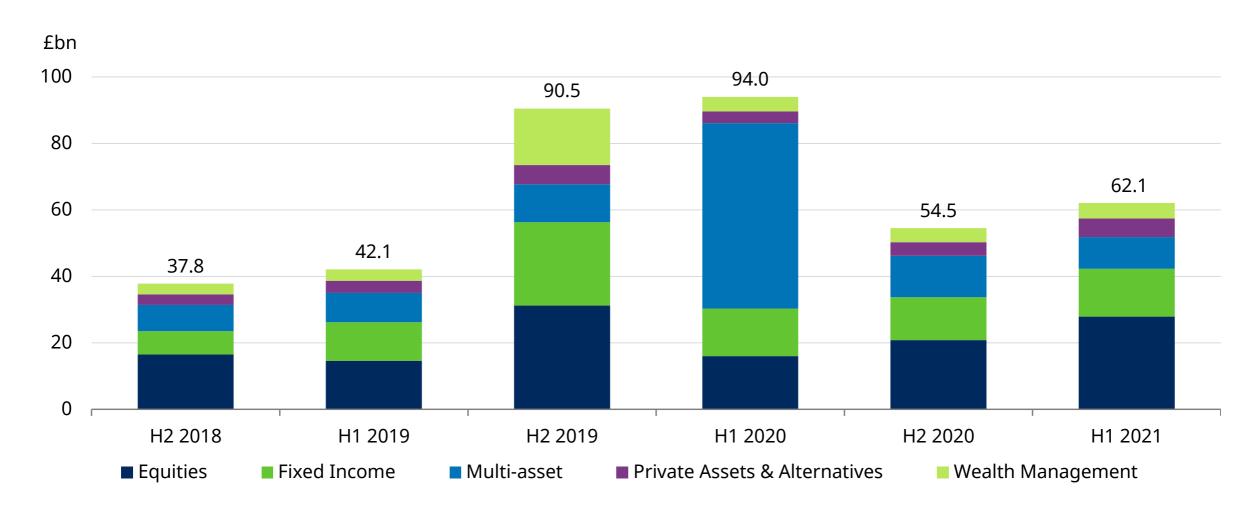

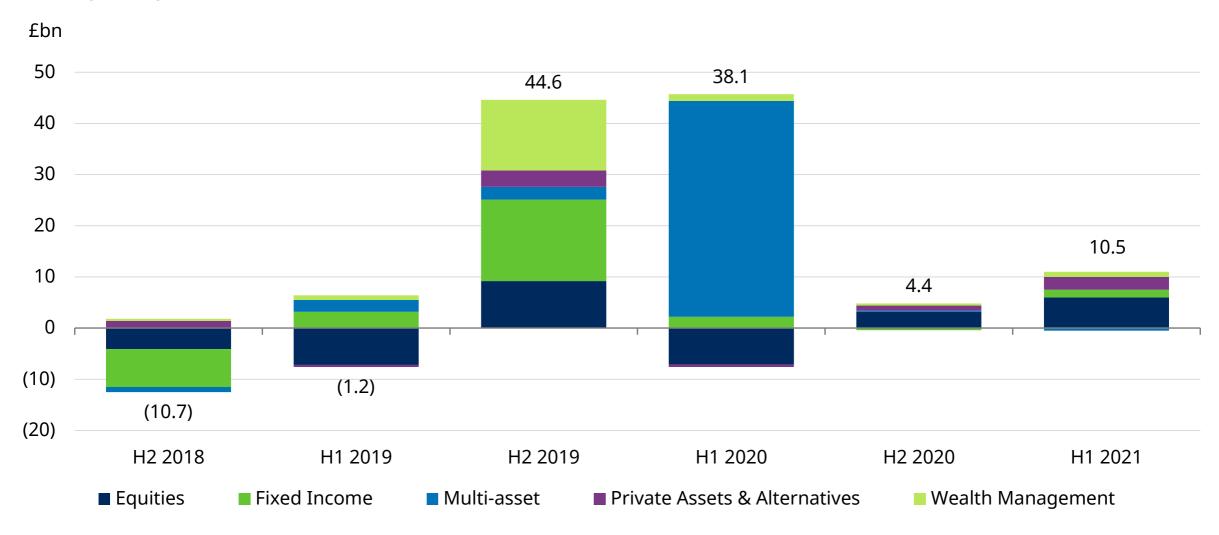
Gross flows excl. JVs and Associates

Half-yearly



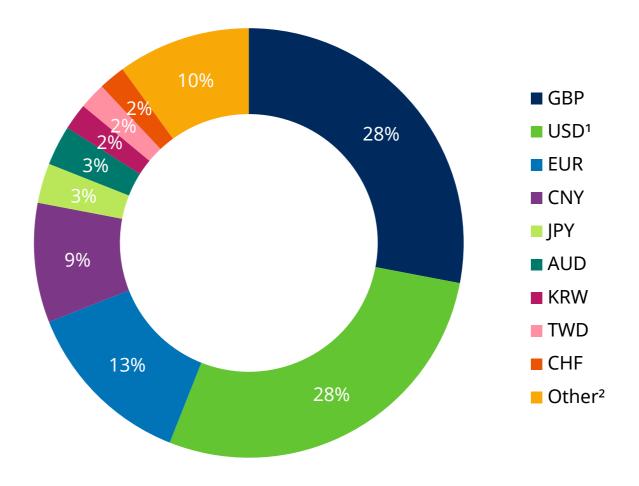
Net flows excl. JVs and Associates

Assets under management £602.4 billion

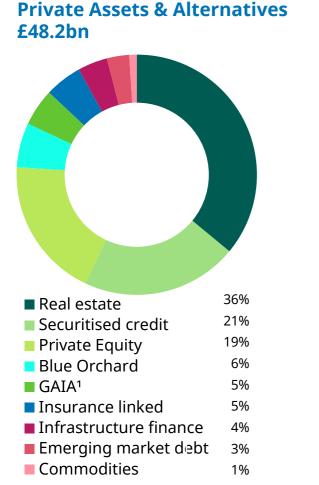


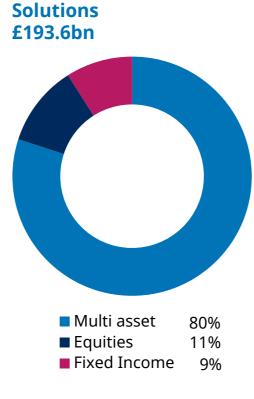

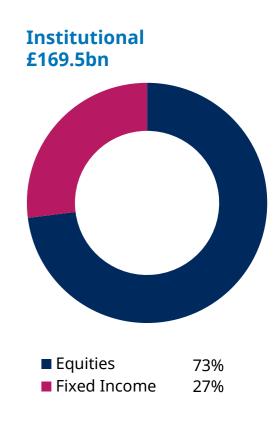

Assets under management £526.1 billion





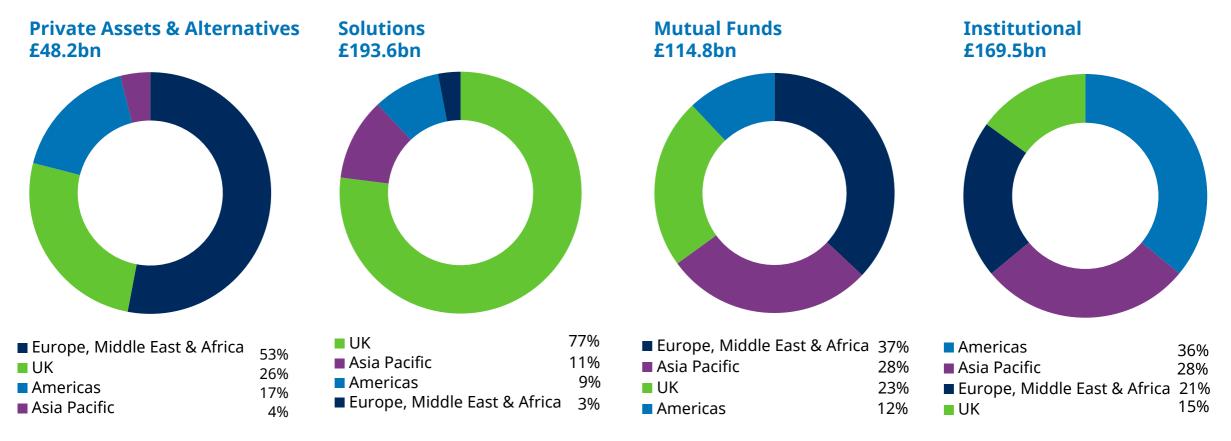

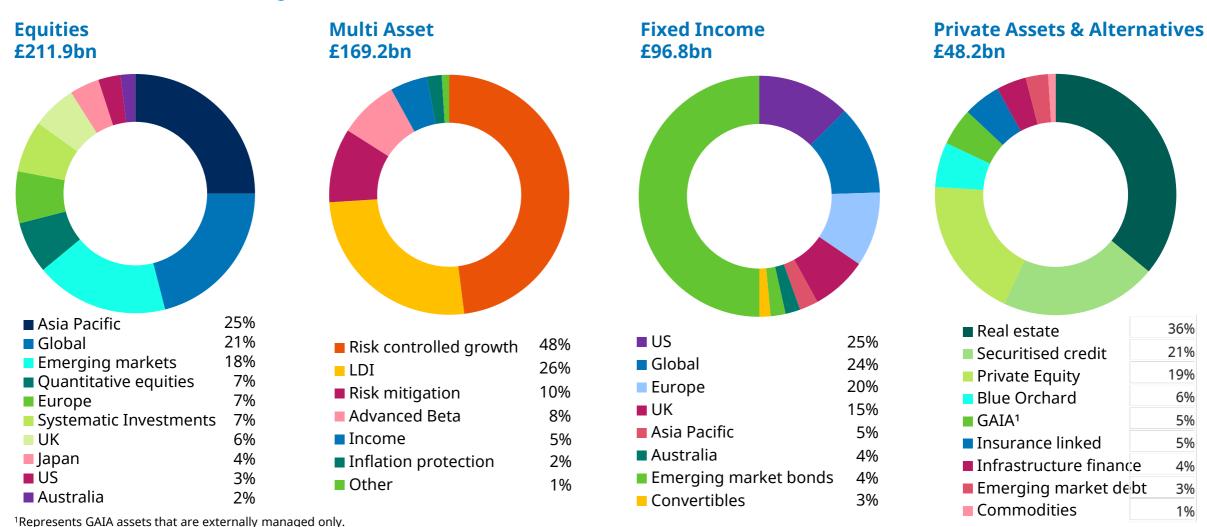
Asset Management AUM – detailed business area analysis

Assets under management £526.1 billion



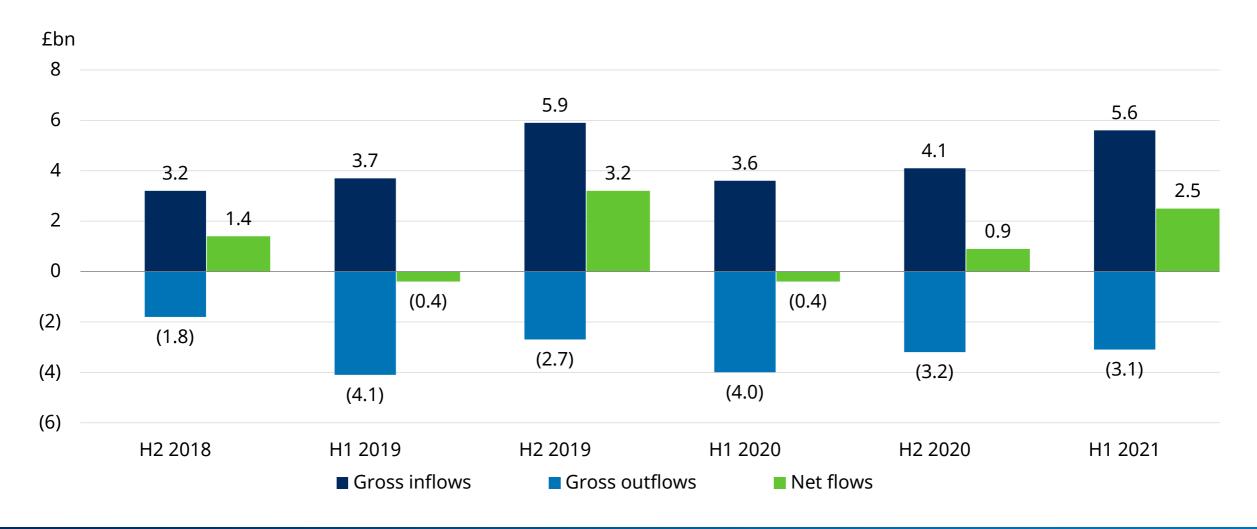
Asset Management AUM – detailed asset class analysis

Assets under management £526.1 billion



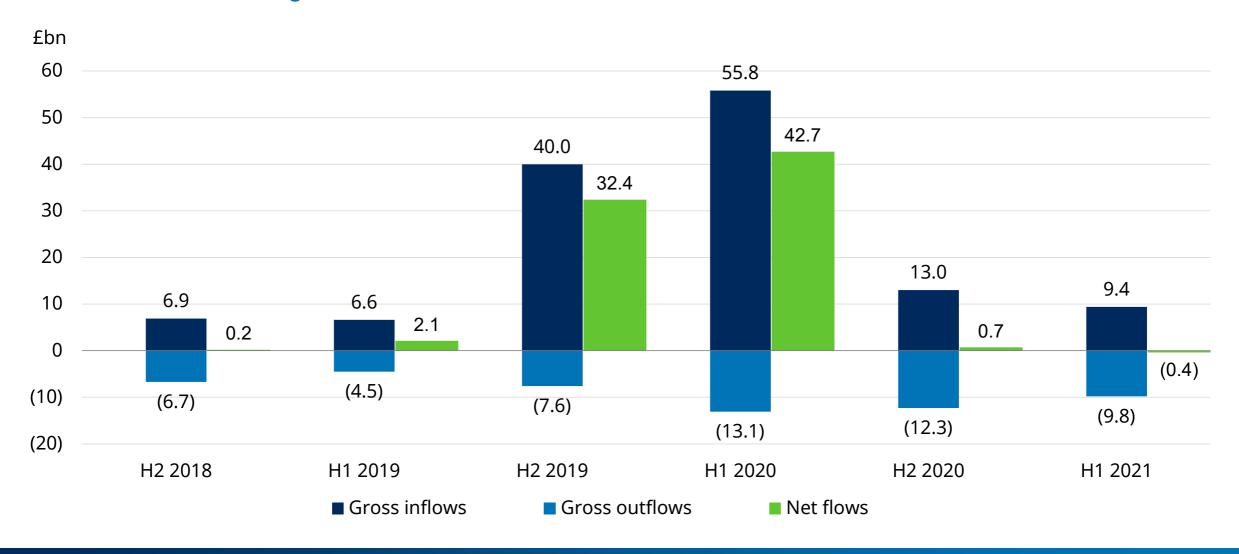
Private Assets & Alternatives – gross and net flows

Assets under management £48.2 billion



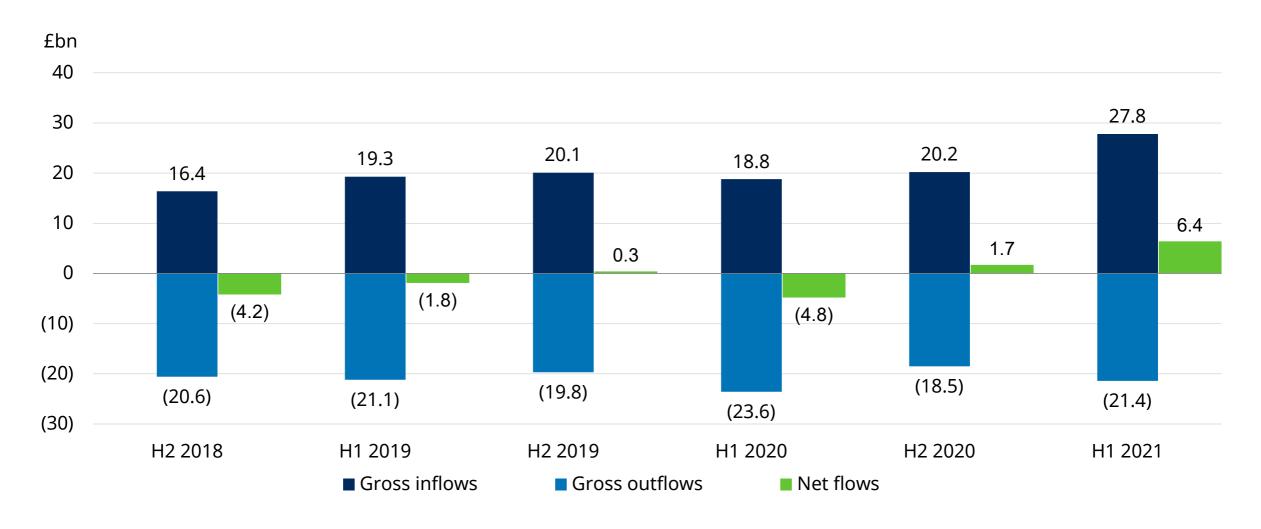
Solutions – gross and net flows

Assets under management £193.6 billion



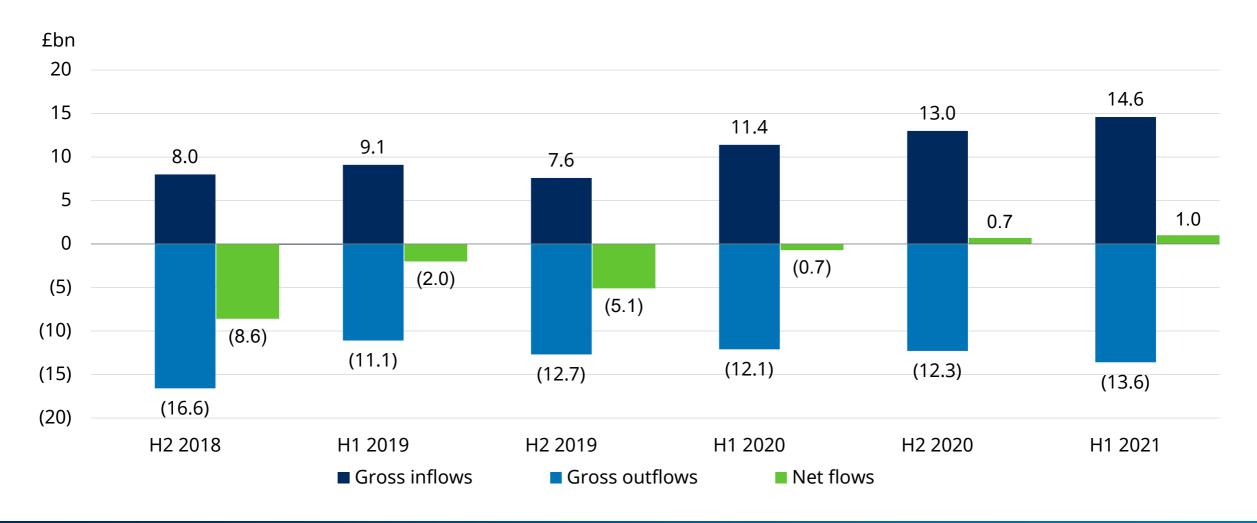
Mutual Funds – gross and net flows

Assets under management £114.8 billion



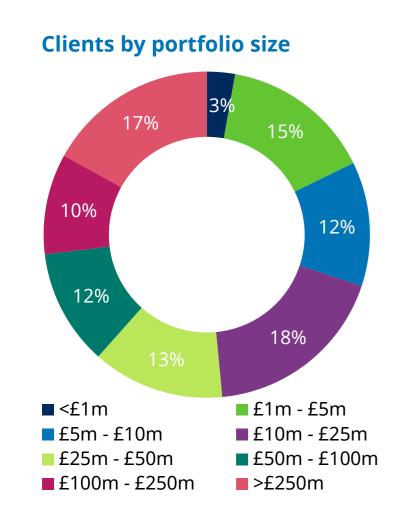
Institutional – gross and net flows

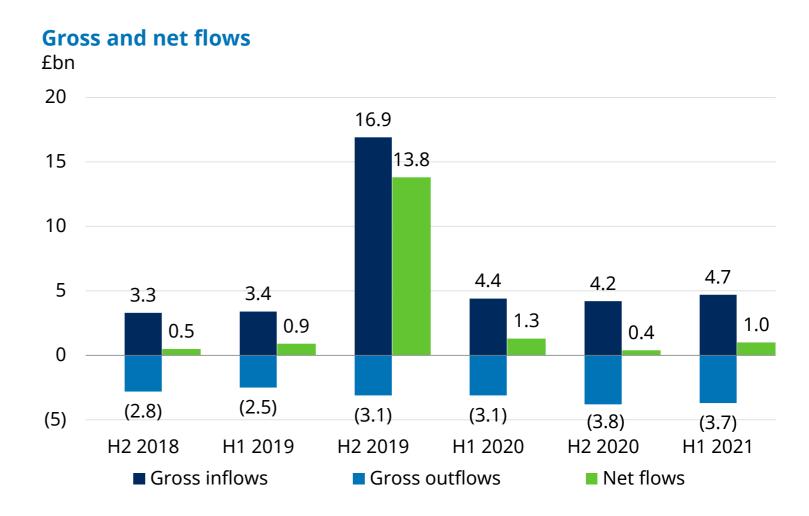
