




Gross flows

Half-yearly




Gross flows

Annually




Net flows

Half-yearly





Assets under management £500.2 billion



Total AUM by business area, region and product





Asset Management AUM by business area and region¹




Asset Management AUM – detailed asset class analysis


Private Assets & Alternatives – gross and net flows

Assets under management £44.2 billion




Solutions – gross and net flows

Assets under management £142.8 billion




Mutual Funds – gross and net flows







