### **Important Notice to Unitholders**

#### **Change in Processing Cut-Off Time for Schroders Managed Funds**

Dear Investors.

We would like to inform you of an important change regarding the processing cut-off time for buying and selling units in those Schroders managed funds set out in the Schedule below. Effective Monday, 1 April 2024, the cut-off time for processing transactions or these funds will be brought forward from 3pm to 2pm (Australian Eastern Standard Time) (AEST).

After conducting a thorough analysis of our managed funds' transaction activity and taking into account standard industry practice, we are making this change to improve the efficiency and accuracy of our transaction processing. Additionally, this change is intended to facilitate best market execution, especially during times of market volatility.

The revised cut-off time means that instructions received by 2pm (AEST) will be processed at the applicable unit price for that business day. However, any instructions received after 2pm (AEST) will be processed based on the unit price applicable on the next business day.

Please take note of the following key points:

- Effective Date: The new processing cut-off time of 2pm (AEST) will be effective from Monday, 1 April 2024.
- **Applicable Unit Price**: Instructions received by 2pm (AEST) will be processed at the unit price applicable for that business day.
- Next Business Day Processing: Any instructions received after 2pm (AEST) will be processed based on the unit price applicable on the next business day.
- **Impact on Transactions**: It is important to ensure that your instructions are submitted before the revised cut-off time to ensure timely processing at the desired unit price.

We understand that this change may require some adjustment, however, we believe that this change will ultimately benefit our investors for the reasons outlined above.
