We are writing to advise you that on **17 August 2023** (the "Effective Date") the investment policies of the Funds will be updated to permit increased indirect exposure (for example, through exchange traded funds or other funds which are China focused) to mainland China or direct exposure for example through Shanghai-Hong Kong Stock Connect and Shenzhen Hong Kong Stock Connect, QFI schemes or regulated markets (including the China Interbank Bond Market via Bond Connect).

Background and rationale

In recent years investments in China have increased as a proportion of the Funds' benchmarks and increased exposure is required in order to take larger positions.

The table below refers to the indirect exposure permitted in appendix III "Fund Details" in the main part of the prospectus of Schroder Special Situations Fund (the "Prospectus") or the investment policy of each of the Funds to mainland China prior to the update (when applicable), as well as the permitted exposure after the intended update of the Fund's investment policy:

The extent of the change to the risk/reward profile of the Funds as a result of these changes is nonsignificant. All other key features of the Funds, including the synthetic risk indicator (the SRI) and fees, will remain the same.

Redeeming or switching your shares to another Schroders fund

We hope that you will choose to remain invested in the relevant Fund(s) following these changes, but if you do wish to redeem your holding in a Fund or to switch into another Schroders fund before the Effective Date you may do so at any time up to and including the dealing cut-off at 1.00 p.m. Luxembourg time on **16 August 2023**. Please ensure that your redemption or switch instruction reaches HSBC Continental Europe, Luxembourg ("HSBC") before this deadline. HSBC will execute your redemption or switch instructions in accordance with the provisions of Schroder Special Situations Fund's prospectus, free of charge, although in some countries local paying agents, correspondent banks or similar agents might charge transaction fees. Local agents might also have a local deal cut-off which is earlier than that described above, so please check with them to ensure that your instructions reach HSBC before the dealing cut-off given above.
